**URGENT PETITION TO THE ASHANTI REGIONAL EXECUTIVE COMMITTEE AGAINST THE CONDUCT OF UNAUTHORISED ELECTORAL AREA COORDINATOR ELECTIONS, CONTINUED FABRICATION OF THE POLLING STATION EXECUTIVE ALBUM, AND BREAKDOWN OF INTERNAL PARTY ORDER, AFIGYA SEKYERE EAST CONSTITUENCY, ASHANTI REGION**

Dear Sir,

I, **Ibrahim Mohamed**, Acting Constituency Chairman of the New Patriotic Party, Afigya Sekyere East Constituency, write to bring to your urgent and immediate attention a serious escalation of infractions in relation to the 2026 internal election processes within this Constituency. What began as a matter of procedural breach and data manipulation has now deteriorated into an open breakdown of internal party order, with elections being conducted in direct defiance of a suspension order issued by this office, and in clear violation of the NPP 2026 Internal Elections Guidelines.

I call upon the Ashanti Regional Executive Committee to step in immediately, assert its authority, and ensure that the right things are done before the integrity of the entire 2026 internal election cycle for this Constituency is permanently compromised.

**1. BACKGROUND, AGREED PROCEDURE AND PRIOR INFRACTIONS**

The foundation of the current crisis was laid by a series of deliberate infractions committed by the Research and Elections Officer, Ernest Ofori Frimpong-Manso, acting in connivance with the NPP Regional Representative, Dr. Samuel Afriyie, in the conduct of the Polling Station Executive Album data entry exercise. These infractions were the subject of formal petitions filed with the Constituency Executive Committee and subsequently with the Regional Steering Committee, and remain unresolved to date.

Two critical provisions govern the process and have been deliberately disregarded:

**The Consensus on Existing Polling Station Executives**

In accordance with the NPP 2026 Internal Elections Guidelines and by consensus reached within the Constituency, existing Polling Station Executives were not to be contested. They were to be affirmed unopposed for their respective positions. This consensus was duly reached and communicated. Pursuant to that consensus, the existing Polling Station Executives duly filed their nomination forms. **Not a single one of them was contested by any aspirant. Not a single one of them was disqualified by the vetting committee.** Every one of them completed the process lawfully, in full compliance with the Guidelines, and was entitled to be entered into the album as the confirmed Polling Station Executive for their respective station.

In these circumstances, for the Research and Elections Officer to unilaterally expunge the names of these legitimate executives from the album and replace them with alien names is not merely a violation of the NPP 2026 Internal Elections Guidelines. **It is a direct infringement on the constitutional rights of those executives**, who participated in a lawful process, were neither contested nor disqualified, and are therefore entitled by right to occupy the positions they duly contested. No officer of this Party has the authority to strip a member of a position they have lawfully earned through a process that was neither challenged nor invalidated.

**The Mandatory Verification and Validation of the Album Before Any Subsequent Elections**

The NPP 2026 Internal Elections Guidelines expressly require that after data entry is completed, a Constituency Album

must be made available for verification and validation before any subsequent elections, including Electoral Area Coordinator elections, can be held using that album as the electoral roll. This is not a procedural courtesy. It is a mandatory prerequisite. No Electoral Area Coordinator election can lawfully be conducted without a verified and validated album serving as its foundation.

## **2. THE FABRICATED ALBUM AND THE UNAUTHORISED SLATING OF ELECTIONS**

As of 15th June 2026, no Constituency Album has been made available to this office or to any Electoral Area Coordinator for verification and validation. The album prepared unilaterally by Ernest Ofori Frimpong-Manso and Bernard Annor, the IT Officer, with the knowledge and involvement of Dr. Samuel Afriyie, the Regional Representative, has never been formally presented to the Constituency Executive Committee for the mandatory verification process required under the Guidelines.

Upon further inquiry conducted by this office, it has been discovered that the album as prepared contains **alien names** introduced by the Research and Elections Officer, which do not correspond to the existing Polling Station Executives who filed forms, were not contested, and were not disqualified. These alien names were inserted in place of the rightful executives in a deliberate scheme calculated to manipulate the composition of the electoral college for the Electoral Area Coordinator elections and all subsequent tiers of the internal election process.

Despite the absence of a verified and validated album, **Ernest Ofori Frimpong-Manso, acting in connivance with Dr. Samuel Afriyie and other agents of the sitting Member of Parliament, proceeded to unilaterally slate Electoral Area Coordinator elections for Monday, 15th June 2026**, without the knowledge, authorisation or approval of this office.

## **3. CONFUSION AT POLLING STATIONS AND SUSPENSION OF ALL ELECTORAL AREA ELECTIONS**

The attempt to conduct Electoral Area Coordinator elections on 15th June 2026 on the basis of a fabricated and unverified album caused immediate and widespread confusion across multiple polling stations within the Constituency. Legitimate Polling Station Executives, who had filed forms, were not contested, and were not disqualified, discovered upon arrival that their names had been replaced on the electoral roll by alien entries. This triggered protests, disputes and disorder at various polling stations throughout the Constituency.

In the exercise of my authority as Acting Constituency Chairman, and in order to preserve order and prevent further irreversible harm to the integrity of the internal election process, **I formally declared the suspension of all Electoral Area Coordinator elections in Afigya Sekyere East Constituency until further notice**. This suspension was necessary, lawful and consistent with my mandate to protect the integrity of the Party's internal processes within the Constituency.

## **4. ELECTIONS CONDUCTED IN DEFIANCE OF THE SUSPENSION ORDER**

Despite the formal suspension declared by this office, one agent of the sitting Member of Parliament, a former Presiding Member by the name of **Michael**, bulldozed his way into one Electoral Area and proceeded to conduct elections in open and deliberate defiance of the suspension order.

These elections were conducted without the authorisation of this office, in direct defiance of a formal suspension order issued by the Acting Constituency Chairman, on the basis of a fabricated and unverified album, in the absence of a verified and validated Constituency Album as required by the Guidelines, and by a political agent acting in the interest of the sitting Member of Parliament and not in the interest of the Party.

**These elections are null, void, and of no legal or party effect whatsoever.** Any results purportedly arising from them must be immediately set aside and cannot be recognised at any tier of the Party's internal structure.

## **5. THE GRAVITY OF THE SITUATION**

What is happening in Afigya Sekyere East is no longer merely a matter of procedural irregularity. It has become an organised and deliberate subversion of the Party's internal democratic processes, orchestrated by the Research and Elections Officer, the Regional Representative, and agents of the sitting Member of Parliament, with the clear objective of predetermining the outcome of the Electoral Area, Constituency and Regional elections through the manipulation of the foundational electoral roll.

The pattern is now beyond doubt. Forms were clandestinely diverted from the Constituency Chairman to unknown individuals. Existing executives who filed forms, were not contested, and were not disqualified had their names unilaterally expunged and replaced with alien entries, in violation of the Guidelines and in infringement of their constitutional rights. No album was made available for verification and validation as required. Electoral Area elections were unilaterally slated without authorisation and in the absence of a verified album. When this office suspended those elections, an agent of the MP conducted elections in open defiance of the suspension order.

Each step has been calculated. Each infraction has been deliberate. The Party's internal leadership must now act with the urgency and decisiveness this situation demands.

## **6. RELIEFS SOUGHT FROM THE REGIONAL EXECUTIVE COMMITTEE**

I respectfully and urgently call upon the Ashanti Regional Executive Committee to:

1. Immediately convene an emergency sitting to address the breakdown of internal party order in Afigya Sekyere East Constituency and issue formal directives to restore order and lawful process;
2. Formally endorse and uphold the suspension of all Electoral Area Coordinator elections in Afigya Sekyere East Constituency declared by this office, pending the resolution of the matters raised herein;
3. Declare null and void the elections conducted by Michael, the former Presiding Member and agent of the sitting MP, in defiance of the suspension order, and direct that no results from those purported elections be recognised at any tier of the Party's internal structure;
4. Investigate the role of Dr. Samuel Afriyie, Regional Representative, in the unauthorised slating of elections and the preparation of the fabricated album, and take appropriate disciplinary action;
5. Direct that the Constituency Album be immediately made available to this office and to all Electoral Area Coordinators for the mandatory verification and validation process required under the Guidelines before any Electoral Area Coordinator elections can lawfully be conducted;
6. Direct that the album be purged of all alien names and reconstructed to accurately reflect the names of the existing Polling Station Executives who filed forms, were not contested, and were not disqualified, in full compliance with the Guidelines and in restoration of their constitutional rights;
7. Direct that all Electoral Area Coordinator elections for Afigya Sekyere East Constituency be rescheduled and conducted only after a verified and validated album has been produced and made available as required; and
8. Take such further steps as the Regional Executive Committee may deem necessary to restore the credibility, integrity and lawfulness of the 2026 internal election process in this Constituency.

## **7. CONCLUSION**

The Afigya Sekyere East Constituency has been subjected to a systematic and deliberate assault on its internal democratic processes. The existing Polling Station Executives of this Constituency followed every rule. They filed their forms. They were not contested. They were not disqualified. They did everything that was asked of them, and they earned their places through a lawful process. To have their names unilaterally stripped and replaced by an officer acting in political interest is an injustice that this Party cannot and must not allow to stand.

The agents responsible have shown, by their conduct today, that they will not be restrained by party procedure or by the authority of this office. They will only be restrained by the decisive exercise of authority by the Regional Executive Committee.

I make this petition as Acting Constituency Chairman, in the discharge of my duty to protect the integrity of the Party's internal processes and to defend the constitutional and democratic rights of every legitimate party member in this Constituency. I call upon the Regional Executive Committee to act with the urgency, decisiveness and impartiality that this moment demands.

The eyes of this Constituency, and of the wider Party, are watching.
